Course Description/Rationale: The course is designed for novice climbers, emphasizing *reasonably* safe, enjoyable and environmentally responsible rock climbing within a *professional/organizational context*. A variety of topics will be covered, including but not limited to: basic climbing techniques; basic safety systems and checks; risk management and mitigation; effective and efficient belaying; rappelling; the proper use and care of climbing equipment, including harnesses, helmets, ropes and hardware; knots; and climbing style and etiquette.

By the end of the course, students will be able to:

- 1. Demonstrate knowledge of and respect for the risks associated with and inherent to rock climbing;
- 2. Utilize standard climbing safety systems and checks;
- 3. Identify, tie and properly apply the basic or standard knots utilized in rock climbing;
- 4. Demonstrate the safe use and care of climbing equipment;
- 5. Explain the significance of climbing style and etiquette;
- 6. Demonstrate a working or practical knowledge of basic climbing and rappelling techniques; and
- 7. Explain basic terms, concepts and principles of rock climbing.

Course Requirements :

Course Requirements & Evaluation

- 1. <u>Technical Skills</u>: 50%. Students will be assessed while demonstrating basic climbing, belaying, rappelling, knot tying and communication skills.
- 2. <u>Written Exam I</u>: 10%. Sunday, March 31 at the end of the indoor climbing/belaying lab and belay skills checkoff. Covers assigned readings and content covered during the lab.
- 3. <u>Written Exam II</u>: 40%. Date to be arranged, typically within a week or two of final outdoor climbing day/
- 4. <u>Fee</u>: \$65.00: covers costs of additional instructor(s) and one day's use of the RU indoor climbing wall.
- 5. <u>Mandatory Attendance</u>:
 - Class/Lab: Tuesdays: Tuesdays, March 19 & 26
 - Indoor Climbing Wall, Radford University: 10:00A 6:00P, Sunday, March 31; Location: Peters Hall, Radford University.
 - Climbing Weekend, Bozoo, West Virginia or *alternative* site; Saturday – Sunday, April 13-14, 9:30A – 6:00P each day. If one or both days are cancelled due to inclement weather, Saturday and/or Sunday, April 27 and/or 28 will be the *backup* days. We need <u>two</u> full days of <u>outdoor</u> climbing to complete course field requirements. If the first weekend allows us two days of climbing, our field requirements will be completed.
 - Depending upon the circumstances, failure to attend all sessions may result in withdrawal from the course, a lower grade, an incomplete grade, or a failing grade. Skills are developed and applied in a *cumulative, sequential* fashion; that time does not permit us to go back and cover previously covered material.
- 6. <u>Active and Safe Participation</u>: Careless or reckless behavior may result in immediate removal and withdrawal from the course, a lower grade, an incomplete grade, or a failing grade. Safe behavior on the part of all staff and students is expected and non-negotiable.

7. <u>Preparation, Clothing & Footwear</u>: Students are expected to prepare and dress appropriately for climbing *and the weather*. That includes being well-rested, completely sober and hydrated before each lab and/or climbing field experience. Minimally <u>half a grade</u> will be deducted *per day* for inadequate dress, inappropriate footwear and/or lack of preparation (more will be deducted depending upon the degree of ill-preparation and dress).

NOTE

Rock climbing has inherent risks, and, regardless of reasonably prudent safety awareness and management, it is impossible to insure or guarantee safety. In the interests of mitigating the risk of unnecessary harm, students are expected to prepare appropriately and adhere to all safety instructions and guidelines.

Grading Policy and Scale:

Written Test 1 -10%

Written Test 2 -40%

Make-up Policy, Late Work:

Assignments will be accepted after the posted due date, but with a point

reduction penalty. Students who miss exams or other major scheduled activities may make them up if a verifiable excuse is provided. In-class assignments and activities cannot be made up, but a point adjustment will be made in the final grading process if a verifiable excuse is provided.
